ABOUT THE EBF



The Economics and Business Faculty Association (EBF) is the official student association for all students at the Faculty of Economics and Business (FEB) at the University of Groningen. Established in 2007, the EBF now supports its 4500 members offering a range of activities and services to enhance their studies, employability, and sense of community.

With approximately 180 active members participating in 24 committees and 3 executive boards, the EBF is Groningen's largest study association. Its activities aim to foster the academic, professional, and personal growth of FEB students and are organized into four main areas: Study, Career, Recreation, and International. Through events like the EBF Conference, EBF/MARUG Recruitment Days, and the EBF Consultancy Tour, the association helps students bridge the gap between theory and practice.

Alongside its formal events, the EBF has recreational events, including monthly socials, active member activities, and parties. The EBF also broadens students' horizons with international trips, such as the European Study Research and International Business Research. To meet the needs of FEB's diverse student body, the EBF has four sub-associations focused on specialized fields: MARUG, FSG, TeMa, and VESTING.

During a board year, each EBF board member gains valuable experience, both in their specific role and in personal development. Read more about the EBF Board roles on the next pages!

THE EBF BOARD



GENERAL INFORMATION

The EBF Board consists of 8 members, each with their own responsibilities, though some tasks are shared across the team. Key responsibilities include working on the annual policy and supervising committees, with some board members providing functional guidance to committee members. The board has board meetings twice a week to ongoing matters, make strategic decisions, and determine EBF's activities. As a board member you attend (almost) all EBF events and some activities organized by the sub-associations. They maintain close contact with active members, faculty, partner companies, and other associations. Serving on the EBF Board is a full-time commitment, offering a dynamic experience and many exciting challenges!

COMMITTEE GUIDANCE

Each board member is responsible for guiding several committees throughout the year. This involves attending committee meetings and regularly holding update discussions with committee members. The time commitment varies depending on the committee, but supporting these groups is a key responsibility for the board that is both enjoyable and rewarding. FUNCTIONAL GUIDANCE

The positions of Chairman, Vice-Chairman, Treasurer, IT & Marketing Officer, and Commercial Officer include providing functional guidance to committee members in similar roles. This means, for instance, that the Treasurer on the board supports all committee treasurers with their responsibilities.



THE EBF BOARD



At the start of the committee year, an EBF Committee Training Day is held, where committee members can participate in role-specific training sessions. Following this, each functional officer provides ongoing, individualized support to the committee members as needed.

POLICY

During the candidate period, you and your fellow candidate board members will develop a policy plan, incorporating both the advice of the current EBF Board and your own ideas. This policy will outline 2 focus points and 2 projects. The focus points are priorities you intend to emphasize in the coming year, and for the projects you are working throughout the year. This means that next to your daily operational duties, you will be actively contributing to the long-term vision and success of the association.

TIME CONSUMPTION AND FINANCIAL COMPENSATION

A board year with the EBF is a full-time commitment. The new EBF Candidate Board is announced in early April, marking the start of a transition period during which your predecessor will guide you through your role and responsibilities. During this phase, you will attend activities and transition meetings to gain experience, while still having the flexibility to complete exams for semester 2.2 or work on your thesis. The official installation of the new EBF Board takes place at the end of June, after which you will be dedicating at least 40 hours a week to your board duties. Evening activities are also a regular part of the role, and board members are expected to participate. To offset the study delay this year may cause, you will receive financial compensation, adhering to certain rules.

CHAIRMAN



As Chairman of the EBF Board, you will be supervisor for the whole association, having a mix of responsibilities and keeping the board motivated. Your main role is to support your board members and make sure everyone is doing and feeling their best. Sometimes this means having formal check-ins and feedback sessions, but often it is just catching up casually, like over coffee every couple of weeks.

Another big part of your job is shaping the EBF's Long-term vision. At the start of the year, you will write out a policy plan with focus points and projects to help EBF grow. You will keep an eye on progress throughout the year and think about the next steps to keep moving forward.

You will also be the face of EBF in a lot of ways. This means building strong connections with other associations in Groningen and beyond, as well as working with the Faculty of Economics and Business and EBF's Sub-associations. Regular meetings with faculty staff are a big part of this, so you will be in the loop on any issues that matter to EBF.

As Chairman, you will work closely with EBF's four sub-associations, meeting monthly with their chairman in the "Platform Voorzitters" to discuss activities, agreements, and ongoing concerns. You will also serve on the supervisory board of each sub-association to review their annual policies and other developments. Additionally, you will supervise the International Business Research Project, and provide guidance to some of the Master Communities. You will also be present at the Faculty Associations Assembly, advocating for the interests of all study associations.

Finally, as chairman, you will represent EBF at both formal and informal events, often delivering speeches, at events like the EBF Conference or Faculty Events. This role requires qualities such as a strong sense of responsibility, empathy, proactiveness, charisma, diplomacy, strategic insights, organisational skills, and long-term vision.

VICE-CHAIRMAN



As the EBF Vice-Chairman, you will take on 4 different roles within the EBF Board. The tasks that come with your position as Vice-Chairman, coordinating different EBF Events with big speakers, guiding the International Development Project and managing the Study Pillar of the EBF.

Furthermore, you will have the spare time to pick up projects of your own interest. The Vice-Chairmanship means working intensively together with the EBF Chairman. Together you will be responsible for the strategy and policy of the association. This includes matching the new policy that needs to be developed with the strategy, mission, vision and long-term strategy of the association. Next to that, you will both be part of the Supervisory Board of the sub-associations and carry responsibility for the several advisory councils of the EBF. With which you will have several meetings per year. Another part of this role is taking over the tasks of the EBF Chairman when this is considered necessary. This could mean that you have to run a meeting, take over external contact or give speeches. Furthermore, you will help organize information activities and ceremonies with the faculty.

You will guide the committees that are in close contact with speakers, such as the TEDx committee. Next to that, you will be the functional guide for all the speakers' functionaries from committees and the first supervisor of the EBF Conference which is the biggest two-day student conference of the Netherlands! Moreover, you will guide the International Development Project, which is a 4-week journey consisting of research and travel across South Africa!

You will take on the responsibility for the study support for EBF Members. This consists of the EBF Booksale, arranging summaries and exam training, thesis workshops and other workshops. You will keep in contact with the study partners of the EBF and safeguard and evaluate the quality of the study support to offer EBF Members the best service possible and look into the needs of the students regarding the study pillar. Most important characteristics of a Vice-Chairman are independence, strategic insight, analytical, confidence, adaptability, empathy and a critical attitude.

SECRETARY & HR OFFICER



The Secretary & HR Officer is responsible for a broad variety of tasks, ranging from formal and administrative tasks to informal ones. You will also be responsible for the Human Resource Policy of the EBF. The position is divided into Secretary-related tasks and HR-related tasks.

As Secretary, you're responsible for all incoming and outgoing communication. You will be the main contact person for external parties, send newsletters to EBF Members, and manage the mail account of the EBF. Another responsibility is event planning for the EBF, its sub-associations, and the faculty. You will work with secretaries from other associations to discuss planning and coordinate with the faculty to align schedules. Additionally, you will take minutes at board meetings, as well as the Half-Yearly and Yearly General Members Meetings, and organize these meetings. Member administration also falls under your responsibilities.

As HR Officer, you are responsible for the international relations and all active members of the EBF together with the Project & Inclusion Officer! You will manage and coordinate the Human Resource Policy, serve as the main contact person for all EBF Members, and organize several activities for Active Members, such as the Active Members Weekend, Dinner, and Committee Training Day. You will guide the Active Members Committee and support them throughout the year in organizing fun activities. You will also guide the First Year Committee and the European Study Research Fall Committee, participating in their activities and trips abroad. Another key task is the recruitment and selection of EBF Committees, Executive Boards, and the next EBF Board. Together with the Project & Internationalisation Officer, you will coordinate committee recruitment in September and February, as well as recruitment for the EBF Conference Executive Board, Recruitment Days Board, and the next EBF Board. Lastly, you will manage the EBF Alumni network, keeping it up to date and organizing three alumni activities during the year, including the Old Board Day.

Are you someone who works precisely and accurately? Someone who likes planning, organizing events and gets energy from being in contact with people? Then the position of Secretary & HR Officer might be for you!

TREASURER



As Treasurer of the EBF, you are financially responsible and play a central role in the organisation. You are ultimately responsible for all budgets, oversee two executive boards, and manage the financial administration and policy. This diverse role involves becoming an expert on financial matters, developing strategies, and working with various stakeholders, such as the faculty and sub-associations. You will also be involved in most of the EBF's projects.

As Treasurer, you oversee the budgets of the EBF Board and assist the treasurers of all EBF committees and executive boards in establishing and updating their budgets. Since nearly every project involves financial aspects, you will have insight into almost all committees, allowing you to stay informed about the organisation's activities.

In addition to your financial responsibilities, you supervise the EBF Conference and International Business Research executive boards, which organise two of EBF's largest events. Guiding these committees and executive boards (financially and operationally) will enhance your skills in providing feedback and making decisions. Occasionally, you will need to defend financial decisions, requiring firmness and tact.

Managing the financial administration will provide you with valuable bookkeeping experience, comparable to working for a company. Additionally, you are responsible for the financial policy and are involved in strategic decisions that impact the budget.

A lot will happen simultaneously, so it's important to maintain a clear overview. While prior experience can be helpful, it is not required; eagerness to learn and develop yourself is more important. Do you have ambition, confidence, a strong sense of responsibility, and precision? Then a board year as Treasurer of the EBF might be for you!

IT & MARKETING OFFICER



As IT & Marketing Officer of the EBF, you have a very broad range of responsibilities regarding all promotional matters. You are not only responsible for the positioning of the EBF, but you will also be guiding 40+ active members, managing the website and data system, coordinating the promotion of the EBF and her sub associations and contacting the faculty. You will closely work together with all other board members and committees which is one of the most interesting and challenging factors.

It is your responsibility that the EBF and her events and services are promoted in the best possible way. Events happen simultaneously all the time and campaigns overlap, so it is important to have a clear and tight schedule, and keep an overview. Furthermore, you will manage all social media channels and offline promotion, such as posters and promotion stunts. The KEI-week and the first weeks of the two semesters are your time to shine, since targeting the (new) students is mainly your responsibility. Managing the marketing campaigns of the EBF is really comparable to a company. That is what makes this position very interesting and challenging at the same time.

Next to that, you will give functional guidance to all PR functionaries in each committee, and you will supervise the Promotion Committee and the Yearbook Committee. It is your task to teach, motivate and advise PR functionaries so that all events are promoted well and they can develop themselves! For almost every organisation, using data for decision making has become increasingly important over the years, as it is for the EBF. Being the IT & Marketing Officer, you will gather and process data so that the EBF Board can make informed strategic decisions. On the EBF Website, students can become a member and sign up for events and it is an important way to inform students about opportunities and events. You will manage this crucial platform, and you will also be responsible for the CRM system and all IT related matters.

Are you creative, good in keeping an overview and planning, and socially-minded and have an affinity with some Adobe applications, Canva, designing, technology and social media? Then the position of the IT & Marketing Officer might be perfect for you!

COMMERCIAL OFFICER



Your goal as EBF Commercial Officer is to maintain, improve, and extend relationships between the EBF and its partners. Over the years, the EBF has built an extensive network of companies interested in connecting with enthusiastic students, and it's your task to facilitate these connections. This challenging role offers significant opportunities for personal and professional development.

Throughout the year, you will visit companies across the Netherlands with the EBF Career Officer. During these meetings, you will primarily engage with company recruiters to evaluate past collaborations and explore opportunities for the upcoming academic year. The partnerships you establish generate revenue, enabling the EBF to organise its events. As Commercial Officer, you have the unique chance to develop yourself while gaining insights into the Dutch business culture. You will also collaborate with the EBF Career Officer to organise career and recruitment-related events, such as the EBF Business Dinner.

In this role, you will guide one Board and one committee. The largest is the Recruitment Days, where you serve on the Supervisory Council to help make this major EBF event a success. Additionally, you will guide the Commercial & Consultancy Committee, which firstly organises a two-day tour to four consultancy firms in the Netherlands, and secondly negotiate for local discounts in Groningen and fundraiser prizes. Many committees also include a Commercial Relations position, and as Commercial Officer, you will guide and support these functionaries.

PROJECT & INCLUSION OFFICER

You will be conducting interviews and selecting the right people for each function, which can be a great puzzle! Inclusion is at the core of everything you do. Whether it's creating an environment where everyone feels welcome or launching initiatives that promote diversity and sustainability, you'll play a vital role in making the EBF more inclusive. With the freedom to develop your own projects, you'll have the chance to turn your ideas into reality and really work in innovating the EBF. CAREER OFFICER

You will guide five out of eight Master Committees, maintain company contacts, and organise events such as the (Pre)Master BBQ, the EBF Skills Day, and supervise the Groningen Consulting Association.

By guiding the Master Committees you'll strive to optimise cohesion between master students & tracks and to integrate them to the EBF.

You will also coordinate one of the EBF's largest events: the EBF/MARUG Recruitment Days. Together with the Commercial Officer, MARUG's External Relations, and the Recruitment Days Executive Board, you ensure its success and long-term development. you are also in the Supervisory Board of the newly founded Groningen Consulting Association. As this part of the EBF is fairly new, you are responsible for their integration to the association and guiding them in a similar matter as the Recruitment Days Executive Board

Alongside the Commercial Officer, you manage the EBF's company portfolio. Together, you acquire partners and organise career events like the Business Dinner and Main Partner Events, acting as each other's sparring partner. The goals: offer relevant career opportunities and generate income for the EBF.

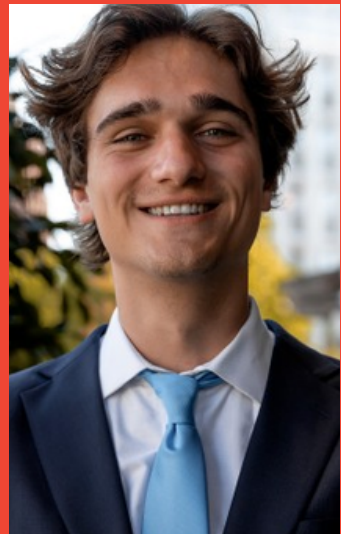


Victor Wiechers was EBF Career Officer (2022-2023)
