# 1. Opening

Rolf Hidding:

Good evening, everyone. I am happy to see you all here, even if it had to be in a digital fashion. So, I'm happy to introduce Inès van Zuijlen as technical chairman of the day. Normally she would come to Groningen and we would welcome her company here physically. Yet despite the COVID-19 consequences that we have to face as EBF, we have decided to move the entire general members' meeting online.

Now I would like to pass the word to Inès van Zuijlen to lead the technicalities of today's General Members Meeting.

Inès van Zuijlen:

Yes, thank you so much Rolf. Ladies and gentlemen, the EBF Board would like to welcome you to the Yearly General Members meeting of the Economics and Business Faculty association Groningen. As you know the General Members Meeting is held online so, please raise your hand in Microsoft Teams if necessary. Before we start off, I am not in the committee that generally leads the General Members Meeting, so first of all, I would like to ask if there's anyone that has any objections against me being the technical chairman of today. If you do so, please unmute yourself and let us know. Are there any people in the room who are not a member of the EBF? Please raise your hand. Yes? Does any object to them being present in the meeting, please unmute yourself. No? Then after the following drop of the hammer, this meeting is officially opened.

# 4. Approval of the minutes from the Half-Yearly General Members meeting dated 8th of February 2021

Inès van Zuijlen:

The minutes of the Half-yearly General Members' Meeting dated on the 8th of February 2021 were recorded by the Secretary & HR Officer and will now be discussed. Inès van Zuijlen: I would like to give the word to Rolf Hidding, Chairman of the EBF Board 2020–

2021, to give a presentation about the Yearly Report of the EBF Board 2020-

# Presentation Rolf Hidding

Inès van Zuijlen: Questions can be asked per topic and if there are no questions for a board

member in the first round then the second round will be automatically skipped. The task division of the EBF Board is presented on page 4 of the documents and also on the presentation. Is there a need for a first round of questions for

Rolf Hidding?



Pieter Kraak:

Thank you for your very broad presentation, I think you have deserved a sip of water after that hour. I have just a couple questions for you, concerning your first policy point. Who desires the data you have collected? Is that a desire from the companies or is it more a desire from EBF at large?

Rolf Hidding:

Thank you for your question, Pieter, I think it's a very interesting one. So, we decided to enhance the information we have as a board and as an association as a whole from our own desires and our own interests, because we know it is important to know what flows through your association, and what type of information you have, to make correct decisions on how to alter things in your portfolio and your association, to better fit the needs of our members. To answer your question precisely, it has been of our own desire and not of a company perspective.

Pieter Kraak:

Okay, so you wouldn't share the data you perceived with firms?

Rolf Hidding:

No, this data would not be shared with firms, also because his data is not very relevant for firms, as it mainly concerns evaluation data of the portfolio that we have, like activities. Maybe that promotional data might be interesting for partners if it concerns promotional activities that we have conducted in their name. But we have not made that decision and we have actually decided not to do so, and use the data ourselves. Also, not to cross any GDPR regulations that we have in the Netherlands.

Pieter Kraak:

Okay thank you, I would like to ask another question concerning the standardization of the forms. Wouldn't you say that by standardizing evaluation forms, you basically have a less thorough evaluation form in the end?

Rolf Hidding:

Yes, also good question Pieter. As I already touched upon in the presentation, there is a balancing act between playing into the specific circumstances and characteristics of a given event, but we think by taking a certain category, like a recreational event, that these events share quite a lot of the same characteristics. Therefore, standardizing questions in this specific category, still makes it relevant for all these individual events themselves. Therefore, not giving away too much information that you collect. I do agree with you, if you make just one standard line of questioning in all the evaluation forms that you have, throughout your entire portfolio, then the information that you gather is very broad and might not be that useful. But we think that by making categories for recreational events, career events, that you can split this quite a lot better, and still play into the specific characteristics and success of an event.

Pieter Kraak:

Okay Rolf, that is very clear. Just to be clear Inès, we have different round of questions per policy point, right?

Ines van Zuijlen:

No, it is per board member, so you can ask all your questions to Rolf now.

Pieter Kraak:

Okay, then I just have one more question. You said that Genkgo wouldn't allow for the proposed changes you have, or at least it would take too much time or

be too expensive. Would you also consider changing or switching hosting parties if the other party does comply with your desires?

Interesting question once again Pieter, as she might as well know, changing from web host entirely, is a very costly process. You will have to build your website from the scratch up, because the templates that we use from Genkgo are not transferable to a different partner, as they have their own copyright and Genkgo build the website for us. It would be very costly, which is a decision that the future EBF board can make if they desire to do so. Yet, we have not used Genkgo for that many years, we still have to figure out within the boundaries we have with Genkgo, to use it to the fullest of its capabilities. I believe we still have to found out where those boundaries lie. It is certainly a possibility, but with the costs involved, we have decided not to do so.

Pieter Kraak:

Okay Rolf, those were my questions and you have given very clear answers, so thank you.

Julian Jager:

Thank you for you clear and extensive presentation Rolf, I have a few questions about the policy. First of all, a question about the TED event. If I am correct, the University now holds a license to hold such a TED event. Does that mean that other associations linked with the University can host also host such a TED event, like VESTING, MARUG TeMa or FSG?

Rolf Hidding:

Thank you for your question, Julian. I think it is an interesting one, but to clarify, we hold the license in the name of the University of Groningen. We possess the actual license, you can't apply for such a license publicly at the University, and ask if you can such an event. We organize it in the name of the University and this can be just one event per educational institution, therefore it is not broadly distributable.

Julian Jager:

Okay, clear. I have a question about the use of Google Ads. You have used Google Ads for certain aspects, have you actually seen some significant impact of Google Ads on for instance the Recruitment Days or the Booksale?

Rolf Hidding:

Once again, a good question. I also mentioned this in the search engine optimization policy as well, it is very hard to isolate the sole effect of Google Ads in the total traffic generated in these periods as we are dealing with a lot of different factors that we have to take into account. For instance, the enhanced digital presence of all students, due to all the services that we offer as all associations, with everything being digital. The total presence of students being online has been higher, therefore that is contributing to an enhance in traffic. So, I could not isolate it's effect. We did manage to see the traffic to our website increase significantly compared to last year. This could be a contribution due to the use of Google Ads but we are not sure if this is the sole reason, due to the other factors that I just described.

Julian Jager:

Okay thank you for the answer. And one last question about the Active Members' Page. As of now, I believe the Active Members' Page is only visible to Active Members. Don't you think that making the page available to non-active members might be a good promotion to become active?

Rolf Hidding:

Interesting question. We firstly decided to focus this on Active Members, to focus on the community feeling that being an Active Member grants. Making it publicly available would undo that benefit it has for our Active Members. Wish you think that we do quite a lot for the integration members involved at the EBF, we think that this improvement that we have launched is best suitable for our Active Members. Yes, for instance providing a sneak peek to what this page entails might interest members to become active. But we think through other policy actions we can better work on creating an inside of what being an active member entails and enhance the appeal it has, such as Instagram takeovers of committees and Active Members.

Julian Jager:

Okay, that sounds clear. Those were all my questions. Thanks.

Kristyn van der Veen:

Yes, thank you Rolf for your clear and very extensive presentation and congratulations on all of your results. I have three questions. The first one is also about data optimization. You already partly answered my question, but the second part of my question was, how did you advise to measure the effect of the search engine optimization on the physically organized events for your successors.

Rolf Hidding:

Thank you for your question, Kristyn. If I understand correctly, your question is how we advise that they measure SEO of the physical events that we organize? Yes, the effect on the physically organized events.

Kristyn van der Veen:

Rolf Hidding:

Good question once again. I think we than refer back to the answer that I provided Julian with as well. It is very hard to isolate the sole effect of one of the changes, compared to all of the different changes that we have also implemented, such as Google Ads. Therefore, I cannot provide you with a clear answer on "what if we can sort out the analyzation of the search engine optimization?". Yes, you could analyze this by for instance not using Google Ads and doing a regression formula controlling for all the different factors that are being in play, and then not using Google Ads to really isolate the effect of SEO, to measure its specific effect. You could do that, but I think that it is not really within our association to do so. We lack the test environment to do so. All right, thank you for your answer. My next question is about the organization of online events. Would you advice the successory board to organize online events next year as well, independently of the circumstances around COVID.

Rolf Hidding:

Thank you for your question once again. Of course, the decisions that our successors make, are their own. We have done our best the last couple to transition our know-how and how we provided our services last year to them. It



might be worthy to do so, but I think that is a question best asked to Lars, in his policy presentation, if they aim to integrate more digital events still in their portfolio.

Okay, so you see your online events as a solution to the current measures of

the past year and not as a future policy plans of the EBF.

Rolf Hidding:

I do think it might be a contributing factor as a whole to your portfolio, that is my personal opinion. It is still up to the EBF Board to decide on what to with the past online practices and if they want to integrate this. But I still think this is a question best asked to Lars.

Kristyn van der Veen:

Kristyn van der Veen:

Yes, I understand. Thank you. My last question is about the LinkedIn structure. Did you also investigate possibilities to include your Alumni's needs and their benefits or capabilities in the new restructured LinkedIn of the EBF?

Rolf Hidding:

Good question once again. So, we think that by appraising the uses of our LinkedIn and making the content that It provides to the feed is also very relevant for our Alumni, as they also mostly follow the EBF LinkedIn page as well. Therefore, we believe that the value that we create also inherently increases the value that we create for our Alumni. We have not specifically investigated the needs and wants of our Alumni as we had our focus on different points this year as I just explained in my policy presentation. It might be worthwhile in future years to investigate what the specific needs and wants in the further expansion of LinkedIn are for our Alumni.

Kristyn van der Veen:

Thank you, those were all my questions.

Lyset de Groot:

Thank you for the presentation and congratulations on all the things that you have accomplished in the last year. Most of questions are already answered but I have one question remaining. It is about the advisory document on all the activities that did not take place this year but that you did put in the document for your successors. I was wondering what action steps and elements are documented in this advisory document and is there still room for your successors to deviate from this.

Rolf Hidding:

Thank you Lyset, that is an interesting question. I think you mean the point that we investigated our portfolio and made an advisory document to further optimize the EBF events that we organized. Of course, the future EBF Board has all the freedom to evaluate on the advisory documents that we made; therefore, they are advisory. We do think that we have made very thorough suggestions to make. About for instance to change the EBF Think Tank to 'Board for a Day', where we put people in the pilot seat and let them control the EBF for a day to also give them insights of what the association means. It is an option to change the EBF Think Tank, but that is something that the future EBF Board can decide for themselves. They have the freedom to deviate from these plans if they so desire.

Thank you, that sounds logical. Those were all my questions.

our insurance. We are not sure about that.

#### 11. Establishment Policy EBF Board 2021-2022

Inès van Zuijlen:

I would now like to give the word to Lars Wartena, Chairman EBF Board 2021-2022 to give a presentation about the policy plans of the EBF Board 2021-2022, and this can be found on page 66 of the documents.

#### Presentation Lars Wartena

Inès van Zuijlen:

Thank you, Lars, for your presentation. Questions can be asked per board member again. If there are no questions in the first round for a board member then the second round is automatically skipped. And the task division will be shown again, it is also present in the documents. Is there a need for a first round of questions for Lars Wartena?

Kristyn van der Veen:

Thank you, Lars for your clear presentation. Congratulations on your policy for next year. I have some questions. To start with, regarding the first focus point of member involvement. You want to open up the introduction camp for second



year students. Did you also think about including premaster and master

students in this camp, or is it solely for bachelor students?

Lars Wartena: First of all, thank you for your question. We have not thought of including master

students as well as these are very diverse from the bachelor students, mostly from the first-year students. We think that the master students have different needs and wants and they would not like to go on such an introduction camp where similar activities are being organized as the previous years. We think we can foresee them with other activities which constitutes to their bonding among

each other.

Kristyn van der Veen: Thank you for your answer, that is clear to me. Then about the personalization

of the emails, how do you plan to measure the success of the personalized

emails?

Lars Wartena: Thank you for your interesting question. First of all, it is then important to have

some kind of a zero measurement, to afterwards evaluate what the effect of the emails have been. We could for example use a survey to see if students are better foreseen in their needs and wants in terms of information being provided about upcoming events and activities. That way, we could see if the separation

is well done.

Kristyn van der Veen: Thank you, then about the second focus point, portfolio optimization. Regarding

the Ski Trip, how big would this event be? Is it open for all EBF members, or do

you target a specific group?

Lars Wartena: Of course, the EBF is a faculty wide association, therefore we target all the

students at the Faculty. About the number of attendants that might possibly join the Ski Trip, we are for the first edition not aiming at too many students. Everything is quite new and we want to make a success out of it. If we start very large from the beginning, making it a success is disproportionally harder.

Currently, we are thinking about 50 people.

Kristyn van der Veen: Okay, sounds like a great idea. Then, about digital environment, why do you

choose to integrate your new CRM system with your current system. Why not

build a whole new system with the functions you desire

Lars Wartena: Thank you for your questions. We have seen in the advice policy of the previous

EBF Board, that the current system has its limitations. Therefore, it would be

convenient to look into other options.

Kristyn van der Veen: Okay, thank you. Have you thought of using a theory like the 'plan, do, check,

act, cycle' with the implementation of the new system? IF yes, what are the

check and act steps of the implementation,

Lars Wartena: Very good idea, we have not thought about that yet. We will definitely take it

into the process, it could be a nice way to get the implementation steps right.

Kristyn van der Veen: Okay, good luck I would say. Then lastly about the sports committee, I like this

idea very much so good that you brought it up. Have you thought of linking the



activities of this committee to sustainability on the health aspect of your

members?

Lars Wartena: Could you elaborate a bit on that question?

Kristyn van der Veen: How would you pursue to link the sports activities to sustainability within the

committee?

Lars Wartena: Of course, sustainability is about different aspects, not only about the

environment but also about humans. In that sense, the human wellbeing can be

linked to the topic of sustainability as well as to sports, I think.

Kristyn van der Veen: Do you have a specific criterion of the green office in mind, which you want to

act upon with these sports activities?

Lars Wartena: In that sense, not yet. I think it is a good idea to think about and we can take it

along the way for introducing the sports committee.

Kristyn van der Veen: Thank you for your answer lars, those were my questions.

Julian Jager: First of all, congratulations to the whole new EBF Board. I am very pleased to

see that our interim generation is now complete and I hope to see you all soon. Lars, thank you for your presentation, I got a few questions about the policy. First of all, about the 'which-committee-suits-you quiz'. Currently, you have a

filtering system to filter committees. Isn't the only new thing added a few new

boxes for the filter?

Lars Wartena: In that regard, we have not decided yet on how to fill that in. But what we have

seen by benchmarking with other associations is that they have a special page on their website. It was more than just clicking the boxes for the committees, it was more thorough to see which committee suits you based on different

aspects.

Julian Jager: Okay clear, and a question about the introduction camp. Does both first and

second year students joining the camp also mean that you have twice as many

students compared to a normal year?

Lars Wartena: Of course, last year has proven that everything is very flexible and we are

thinking that the number of first year students is approximately the same as the last normal year. It might be a bit higher due to the inflow of more students at the Faculty of Economics and Business. For the number of second year students wanting to join, it is for us as well as for the faculty really hard to decide upon that. Though we have still a lot of spots that can be filled because the

capacity of the introduction camp is quite large.

Julian Jager: Okay, so probably more people will be joining the introduction camp. From my

own experience, an introduction camp can be very chaotic. How do you make sure that everything will go fluently, when way more people are joining? Are

more people involved in the organization of the event?

Lars Wartena: Thank you for your question. Of course, we have a committee that organizes

the introduction camp. We also have a lot of camp leaders and camp mani's



helping the Introduction Committee. I think we have to expand on that if more

people join the camp.

Julian Jager: Okay, clear. One more question about the skiing trip. When are you planning

on going on the ski trip? I can understand that the faculty won't that happy if you plan a skiing trip during a regular lecture week but also a weekend might be a

little short for a ski trip. Do you already have a time planned?

Lars Wartena: Thank you. The proposal we made is about the ski trip taking place in week 5.

This is at the end of January 2022 and that means that the resits of the first block take place. If people have no resits, their study results are not affected

and we thought that would be an important aspect for the faculty.

Julian Jager: Okay, but beforehand people have to sign up. What if they end up having a

resit?

Lars Wartena: Our idea was to already promote at the beginning of the academic year, if the

ski trip of course takes place. That way, people can already put some money aside for the trip, but besides they know that they can join the trip only if they

have a sufficient score for all their courses in the first block.

Julian Jager: Okay, so people can only apply after the first block, when they already know

their results and if they have resits?

Lars Wartena: Exactly.

Julian Jager: Okay, clear, thank you, those were all my questions.

Pieter Kraak: Lars, from my side as well, clear points that you want to work on. I think you will

have your hands full on that. So good luck in advance. I have a couple of questions. First of all, about the Local Company Event. I was wondering what drove the decision to actually organize this event. Was it sending out a questionnaire to your members and finding out that this was desired, were

partners a driving factor or did you simply assume that this was needed?

Lars Wartena: Thank you for your question. Good question indeed. We saw from the advice

policy by the previous EBF Board that some new type of company event might be appreciated by the members of the EBF. After some brainstorming sessions and adding a question in the survey, we came to the conclusion that this might be a possible event for students. We will first set up a pilot year to see if the event has sufficient attendance. We think that by good promotion we will

foresee in that.

Pieter Kraak: Okay so by sending out a questionnaire amongst your members you found out

that this was actually a nice event, for a pilot at least?

Lars Wartena: Yes.

Pieter Kraak: Okay, good to know. And secondly, you want to expand the tasks of the EBF

Speakers Committee with quite a lot of things. Like an EBF podcast and the TEDx event. Wouldn't you say this increases the workload of this committee,

and if so, how would you deal with that?



Lars Wartena:

Good question Pieter. I think normally people would think that quite immediately. Of course, adding quite a large event like a TEDx event and possibly an EBF podcast would increase the workload quite a lot. However, over the last years we have seen that the Speakers Committee has quite some ups and downs in terms of workload throughout the year. We think that by adding these two events or activities we can make the workload more evenly and therefore it won't make the workload too much. They can work on some activities and events throughout the year and not at specific points in time.

Pieter Kraak: Lars Wartena: Okay, was this already done in corporation with the committee as it is now? No, not yet. This is because the TEDx event has not been introduced to the committee yet. Of course, we are looking into the possibilities of a podcast. In that regard we are not sure if this plan will go ahead, and if it will be introduced throughout the year it will definitely be discussed with the committee.

Pieter Kraak:

So, you might add another member than if the workload becomes too much?

Lars Wartena:

For example, yes. That might be a good possibility.

Pieter Kraak:

Okay, those were my questions. Thank you very much Lars.

Lyset de Groot:

I have one question left and that is regarding the community forming second year events. What are your ideas on how you will form this community among the second-year students?

Lars Wartena:

Thank you for your question, Lyset. We are currently aiming at introducing a sort of SPAA/SSG dinner for them. It is very important and it came out of conversations with the faculty that they would really like to create a community among students from specific studies. For example, we would make groups based on groups that are in the same tutorial. This way, they would already know each other a bit from their studies and they can form a group for the event. Okay, since the second and first-year students are all invited to the introduction camp, will you also be aiming at a larger community combining the first year and second year students?

Lyset de Groot:

Lars Wartena:

Good question. We are currently really investigating the possibility to open up the introduction camp. Of course, they can socialize among each other but the setup of the introduction camp would be to create two communities. They can party together but the planned activities will be separate for them.

Inès van Zuijlen:

Is there a need for a second round of questions for Lars? Okay, Is there a need for a first round of questions for Niels? Okay, then the second round is automatically skipped. Presentation Wendy

Inès van Zuijlen: Thank you so much, Wendy. Is there a need for a first round of questions for

Wendy Schoonderbeek about the financial policy?

Tim Bonte: First of all, congratulations on becoming the treasurer of the EBF upcoming

year. Right now, it sounds like an amazing financial report. I have one simple question. Shouldn't a negative interest be part of the expense statement instead of the revenue statement? Because now you have it budgeted on the expense

statement at the moment.



Wendy Schoonderbeek:

Thank you, that is a very fair question. For now, it is firstly, the first time that it is going to be negative and therefore the ledger account is still included in revenues. Secondly, we are still looking for ways to mitigate this. Therefore, it is not sure yet that it will actually be a loss. If it shows that it is going to be a loss and that we can expect this to be a loss for the upcoming years, I can consider moving this ledger account. For now, I did not yet see a reason to.

Tim Bonte:

Okay, thank you.

Jasper Platte:

Thank you for your presentation, Wendy, it was really clear and I hope we can meet soon. I had a question about the fact that you're still hiring an external location for your office. This is quite expensive; do you think this is still necessary? It is also possible to work with a few people at the Interim and it is possible to work online.

Wendy Schoonderbeek:

Jasper, thank you for your question and I hope to meet you soon as well. To start, accommodation costs are not only the rental costs of the office. It is for the larger part but there is also a small budget for reparations that need to be potentially carried out at the interim. We do believe that actually renting this office is a requirement. We know that the Interim is opening up, however there are limited spots and not room for everyone. Therefore, we want to allocate these spots to the executive boards and sub associations as we have the funds to rent this external location. However, as I said, as soon as we can take place at the Interim, we will do so.

Jasper Platte:

Okay thank you. That is clear. I have one other question regarding the transportation costs. You have increased that budget because you think the situation is going back to normal. Do you also take sustainability into account when making this budget? It is also possible to meet online and that is more sustainable.

Wendy Schoonderbeek:

Thank you again Jasper. It is a great question. I personally, and with me the entire 15th EBF Board, and surely the 14th EBF Board regard sustainability as very important. We do take this into account, for example all company visits are carried out by going there by train. This is a relatively sustainable way of transportation.

Jasper Platte:

Thank you. I have no other questions.

Inès van Zuijlen:

Thank you, Jasper. Is there need for a second round of questions for Wendy about the Financial Policy? Are there general questions concerning the Financial Policy? Is there a need to put it to a vote? Upon the following drop of the hammer the Financial Policy of the EBF Board 2021-2022 will be
